GIVEAWAY  
TERMS AND CONDITIONS**

1. The promoter is the Sydney Swans Football Club, Royal Hall of Industries, 1, Driver Ave, Moore Park, NSW 2021 ABN 48 063 349 708 (“**Promoter**”).
2. The Sponsor is Carnival plc trading as Princess Cruises (ABN 23 107 998 443) or Level 5, 465 Victoria Avenue, Chatswood, NSW Australia 2067, phone (02) 8326 4000 (“**Sponsor**”).
3. Instructions, prizes and information on how to enter form part of these Terms and Conditions. By entering, entrants accept these Terms and Conditions.

**Entry**

4. The Promotion commences at 00:01 25 June 2024 and ends at 23:59 31 July 2024 (“**Promotional Period**”). Entries must be received within the Promotional Period.
5. Entry is only open to Australian residents aged 18 year or over.
6. Employees of the Promoter and their immediate family and agencies associated with this Promotion are ineligible to enter. Immediate family means any of the following: spouse, ex-spouse, de-facto spouse, child or step-child (whether natural or by adoption), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or 1<sup>st</sup> cousin.
7. Incomplete or indecipherable entries will be deemed invalid.
8. The Promoter reserves the right, at any time, to verify the validity of entries and entrants (including an entrant’s identity, age and place of residence) and to disqualify any entrant who the Promoter has reason to believe has breached any of these Terms and Conditions, tampered with the entry process or engaged in any unlawful or other improper misconduct calculated to jeopardise fair and proper conduct of the Promotion. Errors and omissions may be accepted at the Promoter’s discretion. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights. The Promoter’s legal rights to recover damages or other compensation from such an offender are reserved.
9. Any costs associated with entering the Promotion, including data costs, are the entrant’s responsibility.

**How to Enter**

10. To enter, during the Promotional Period individuals must:

11. Only one (1) entry per person will be permitted.
12. All eligible entries will be entered into the draw (the “**Entry**”).

**Prize**

13. The total prize pool value is up to AU\$1,000 (incl. GST).
14. There is one Major prize to be awarded. The Major Prize winner will win:

**The Draw**

15. This is a game of chance. Skill plays no part in determining the winner.
16. The draw will take place at 1 Driver Ave, Moore Park, NSW 2021 on [1 August 2024 at 14:00]. The Promoter may draw additional reserve entries and record them in order in case an invalid entry or ineligible entrant is drawn. A draw for the prize, if unclaimed, may take place on 4 August 2024 at the same time and place as the original draw, subject to any directions from a regulatory authority.
17. The winner will be notified in writing by email within two (2) business days of the draw.
18. Subject to the unclaimed prize draw clause, if for any reason the winner does not take/ redeem the prize (or an element of a prize) at or by the time stipulated by the Promoter, then the prize (or that element of the prize) will be forfeited.
19. In accepting the prize, the winner acknowledges that they may incur ongoing costs associated with the prize that are the responsibility of the winner.

**General**

20. The Promoter's decision is final and no correspondence will be entered into.
21. The Prize is subject to availability. If the Prize (or part of the Prize) is unavailable, the Promoter and Sponsor, at its discretion, reserves the right to substitute the Prize (or that part of the Prize) with a prize to substantially equal value and/or specification, subject to any written directions from a regulatory authority.
22. With the exception of any expenses specifically included in the Prize, all:
  - a. costs associated with transport to/from the departure port will be the responsibility of the winner and accompanying guest and will not be borne by the Promoter or Sponsor; and
